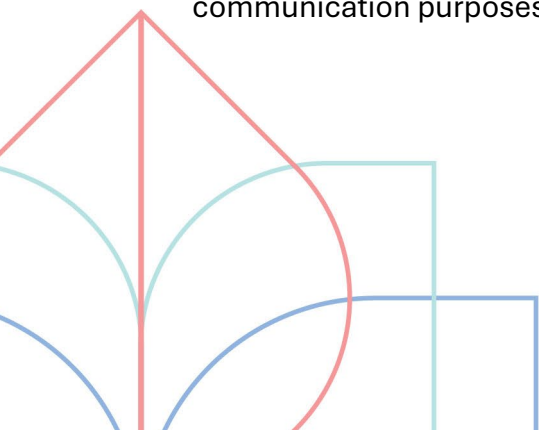
2. WEBSITE USE AND RESTRICTIONS

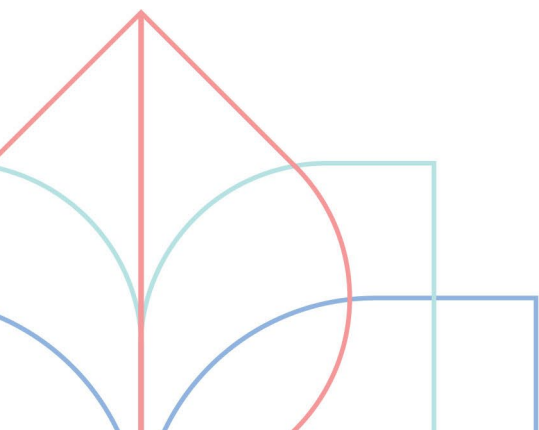

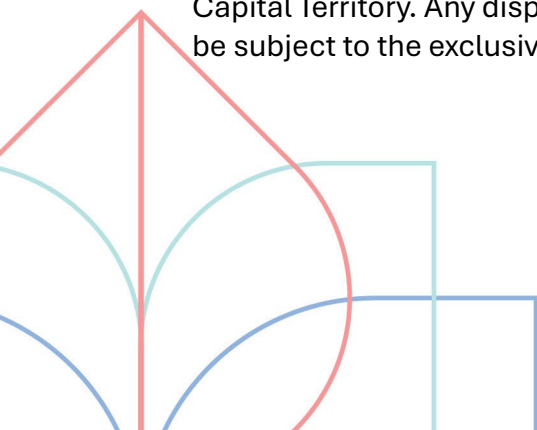
